## EVENT TERMS & CONDITIONS

- Vendor booths must be manned during all show hours.
- Vendors must be prepared to fully stock booth for the entire duration of the event.
- Vendors must be checked in & completely set-up by 9:45am on each day of the event.
- AriensCo Hospitality reserves the right to inspect all displays and remove any merchandise deemed inappropriate for the event. All products being sold must be listed/described on page 1 of this contract.
- AriensCo Hospitality is a non-smoking property. There will be no smoking at the event.
- Vendors shall clean up all debris from their assigned space(s), during and at the conclusion of the event. (There will be dumpsters available on site if needed)
- Appropriate attire shall be worn by Vendors at all times during the event.
- AriensCo Hospitality is not responsible for lost, stolen or damaged items.  
(It is recommended that all products are placed in plastic storage bins with lids (off the ground), and covered with tarps at night, as this is an outdoor event.)
- Vendor parking will be assigned. You will be notified prior to the event, as to where vehicles and trailers should be parked before, during, and after the event. Load-in and load-out information will also be given.
- All Vendors must provide their own tenting, tables, chairs, carts, display materials, etc. for the event.
- All Vendors must carry their own insurance on their products, including liability insurance on all food items.
- All Vendors must be completely dismantled by 6pm on Sunday, May 12, 2024.
